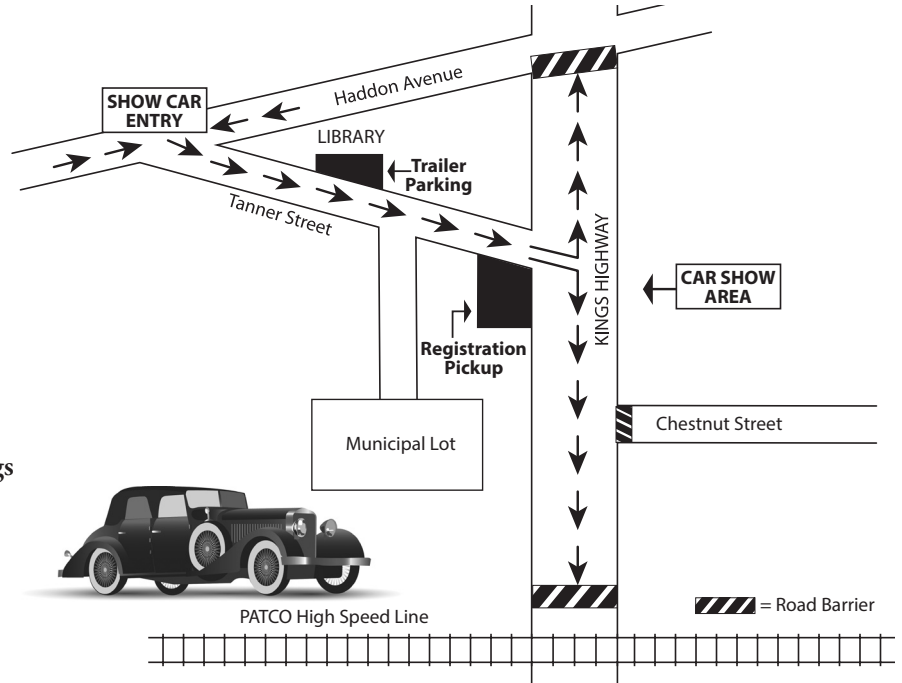
# HISTORIC HADDONFIELD

### **JUDGING STANDARDS**

1. Auto must be on judging field and ready for the judging process by 11am on the day of the meet.
2. Owner has the responsibility of verifying the information on the front of the judging sheets is complete and correct.
3. The Owner or representative must be with the vehicle during the judging process.
4. Owner or representative is responsible for discussing any authenticity discrepancies with the judging team during the process.
5. All vehicles must be ready for judging which means the following:
  - a. All windows must be up
  - b. Hood and trunk are to be opened (nothing in the trunk)
  - c. All doors must be unlocked
  - d. Owner must be there to open doors for the interior judge
  - e. All convertible tops must be in the upright position
